1. **Payment and Paper Entry Form DUE on or before August 20th.** Photos due later see rule #6.
2. Open to amateur photographers only. Persons who support themselves or are rewarded for their work will be considered professional and cannot exhibit
3. Photographs no larger than 8 X 10, mounted no larger than 11 X 14, no thicker than 3/16.”
Matted - No Frames.
4. Digital photographs accepted.
5. Open to all ages
6. **Photos must be delivered Sunday, August 25th NOON.** No entries will be accepted after this time. Mail in entries will be accepted and must be sent to P.O. Box 257, Chatham, NY 12037, marked “Photo Contest.” **Entry fee must be included.**
7. All Entries must be on a fair entry form and include a 3x5 card with entrant’s name, address, phone number and photo location
8. Photo location must be the Columbia County area only.
9. Only one entry in each class- a **maximum of three photographs** per person.
10. Photographs can be claimed following the fair from 9am-4pm **at the Administration Office.** After Oct 31, we will no longer be responsible for your photos.
11. Photographs will be judged on the following:
 - a. Creativity
 - b. Impact
 - c. Composition
 - d. Technical quality
 - e. Story telling
