### Rules and Regulations

- Payment and Paper Entry Form Due on or before August 20<sup>th</sup>.
- Entered items will be accepted for judging by **Monday, August 26<sup>th</sup> before 5pm.** Entries must remain on display until Monday, September 2<sup>nd</sup> at 9 PM or pick up Tuesday, 2 PM.
- All entries must have a tag or label attached with: name, address, section, and class in which the item is entered.
- No refunds on any entry that is withdrawn.
- All sections in the Adult section are open to amateurs. Professionals; persons who support themselves or are rewarded for their work will be considered professionals and can only enter in that category.
- Construction of entry must be completed before entry
- Item must be 75% duct tape
- Items should be of good clean nature, nothing vulgar or suggestive

Creativity 30%  
Appearance 20%  
Difficulty 10%
